

# Fubon Life Hong Kong E-Channel Terms of Use

#### 1. Conditions of Use

- 1.1. Please read these Terms of Use carefully. By accessing and using this website, you agree to be bound by all the following terms and conditions, which shall be governed by the laws of Hong Kong, any disputes arising thereof shall be subject to the exclusive jurisdiction of the courts of Hong Kong. YOUR ACCESS TO AND USE OF THIS WEBSITE IS AT YOUR OWN RISK. These Terms of Use may be modified from time to time without prior notice, and it is your responsibility to periodically review the most up-to-date version of these Terms of Use posted in this website.
- 1.2. Fubon Life Insurance (Hong Kong) Company Limited ("Fubon Life Hong Kong", "we", "our" or "us") has the right to determine and vary from time to time the scope and type of services to be made available through this website, including imposing and varying any restrictions on the use of the services, and prescribing and changing the services hours without prior notice. ## 4. Online application for insurance products

- 4.1. You confirm that your access to and use of the website, including the application for insurance product, any other transaction or use of services on this website, is legal and not prohibited by laws and regulations applicable to you. You understand and agree that YOU MUST BE HONG KONG PERMANENT RESIDENT AND PHYSICALLY IN HONG KONG WHEN YOU MAKE APPLICATION FOR INSURANCE PRODUCT ON THIS WEBSITE.
- 4.2. In order to apply for insurance product on this website, you shall provide us with your accurate and valid email address, mobile phone number and identification documents. You may also be required to upload your own photo for verification of your identity. You agree and acknowledge that the application for insurance



product by any person (whether authorized by you or not) with your email address, mobile phone number, identification documents and/or photo shall be deemed as application for insurance product on the website by yourself. Fubon Life Hong Kong is not responsible or liable for (and has no obligation to further inquire or investigate) any wrong or misspelled email address or inaccurate or wrong mobile phone number, even if you can prove that the instructions were not sent by you or without your authority. Fubon Life Hong Kong is entitled, at its discretion, to seek your confirmation offline or require other additional authentication processes or methods on any of your instructions as and when so deems fit.

- 4.3. You warrant that all information disclosed in the application of insurance product are complete, true and accurate. Upon your completion and submission of the online application, an application summary will be generated, which constitutes the Life Insurance Application Form and become part of the policy when the policy is issued. Upon we have received the application in our record, we will process the application and inform you by email, mail and/or SMS when the policy is issued. The insurance coverage provided under the insurance policy in the application on the website shall not commence until the policy has been approved for issuance and that



Fubon Life Hong Kong has received the initial premium during the lifetime of and while the Proposed Insured is in good health.

- 4.6. In the application for insurance product on the website, you may be required to make payment through third party providers. By making payment through third party providers, you agree to be bound by the terms and conditions of the third party providers. We are not responsible for any errors of the third party providers. You are responsible to ensure the payment information you provided is correct. Your confirmation of payment may not be received by us for reasons including mechanical, software or computer failure or the omission or failure of third party providers. To the extent permitted by law, Fubon Life Hong Kong shall not be liable for any direct or indirect harm or loss you may suffer for this reason.
- 4.7. You agree that Fubon Life Hong Kong can provide you with any document, including but not limited to notices, records and any type of documents (including the policy contract) in relation to your application for insurance products on the website to the email and/or correspondence address provided by you. You also agree Fubon Life Hong Kong to provide information to you via SMS to the mobile phone number provided by you. You agree that electronic delivery of a document has the same legal effect as if we provided you with a physical copy. We will not be responsible in the case that a document is not received by you due to your email and/or correspondence address having changed or being invalid or due to system failure, interruptions in the communications systems or other reasons outside our control. You further agree that electronic documents will be admissible as original documents in any court of law in Hong Kong.
